## ALL PARTIES AGREE THE FOLLOWING:

- All outstanding fees shall be payable in cash / cheque / BACS seven (7) days before the date of the Engagement. (delete whichever is not applicable)
- Performances in addition to those specified in Clause 1 above shall be subject to fees and conditions to be agreed between both parties.
- All equipment and instruments of the musician(s) performing the engagement are not available for use by other performers or persons except by specific permission of the musicians concerned.
- Adequate light and seating will be provided by the Engager.
- Changing and storage facilities will be provided by the Engager.
- The playing out of doors shall only take place weather conditions permitting and if suitable cover is available when sunny.
- No photos or videos shall be made of the performer(s), without her / their prior permission.
- Suitable refreshments will be provided by the Engager as specified and agreed.
- The Engager should ensure as far as is reasonably practicable, that all necessary steps are taken to provide safe working conditions for the musician(s) engaged under the terms of this contract.
- In the event of the cancellation of the Engagement, the Engager will be subject to pay the following cancellation fees: up to four (4) weeks before the Engagement, 25% of total fee - up to three (3) weeks before the Engagement, 50% of the total fee - up to two (2) weeks before the Engagement, 75% of the total fee - up to one (1) week before the Engagement, 100% of the total fee.
- This Agreement may not be modified or canceled except by mutual consent in writing and signed by both parties. Any such modification or cancellation shall not prejudice the right to payment of the musicians engaged by the Leader.
